Law Farms LLC's Popcorn division offers a unique way for your group to raise money. We offer a variety of tasty, freshly made treats that are grown and popped right here on our family farm in Northwest Missouri! By choosing to work with us, you help keep the local economy moving as we support several other area businesses in the production of our popcorn.

If you choose to conduct a fundraiser with us, we supply your group with fundraising sales sheets to sell our large 12x20" bags of gourmet popcorn. The plain and sprinkle on flavors retail at **\$15** each for the fundraiser with your group keeping **\$7.50** for each of those bags sold! The flavors involving chocolate or cameral glaze or combo bags with 3 smaller bags retail at **\$30** each with your group keeping **\$12** per bag sold! The money your group maintains from our fundraiser is outstanding compared to other fundraisers offered in the area. You will find a copy of the sales order form with list of available flavors attached to this letter.

All payments are taken and made to your organization at the time of the order. Your organization then makes one payment to Law Farms, LLC upon delivery of the group's order. The delivery date and sales cut off time is agreed upon between your organization and Law Farms, LLC prior to starting the fundraiser. Individual order sheets for each person selling in your group will not be accepted. Rather we will need a list of total bags sold per flavor for the entirety of the group's orders. Your group must provide a sales tax exempt letter at time of delivery or sales tax will be added.

Typically groups sell the popcorn for 2-3 weeks and then turn in a total per flavor needed. We deliver the popcorn one week later at the agreed upon time. Once the bags are unloaded, the organizer of the fundraiser will be asked to double count the bags of popcorn delivered and will additionally be asked to sign off on the delivery sheet that all popcorn bags are accounted for. If more bags are needed later, we will gladly pop more and arrange for pickup or drop off of the extra bags. We generally have a few extra bags of random flavors after popping for fundraisers. We share those extra bags of popcorn at no cost as a bonus to the group. For churches we have found that delivering the day of bible study or on Saturday works well so the patrons of the church can pickup when they attend.
